- e) Update on traffic issues

(Taken after item 4 of the agenda with an invitation to members of the public to take part). Background is a number of near misses caused on Moor Road where motorists have been overtaking slower moving vehicles . Two Police representatives in attendance.

- PC Steve Dennis can only find a few complaints recorded and to be able to take it further he needs to be able to evidence 40/50 reports to get any action from the County Council.
- He is aware of individual vehicles and a picture submitted will be acted on personally.
- Cars are pulling on the kerb (especially where there are double white lines) if less than 5MPH that is acceptable.
- A vehicle has to be left in a dangerous position (obscuring view or not leaving width of a mobility scooter) for action to be taken.
- Reports with photographs ca to local Council ASB team or via the Parish Council e-mail for submission to PC Dennis (as BVPC know which Council is responsible for the location involved).
- The behaviour is linked with the cushions are creating a hazard rather than alleviating them. Wider vehicles can drive over them and are frustrated by those who can't.
- Technology has moved on and Speed cameras are thought to be the way forward but the Police need to get evidence (via 101 or similar) to be able to fight on behalf of the residents.
- It is unlikely that the humps will go (£500,000 plus based on County prices) to remove the pads that will then create potential road surface issues in the future.
- A request for more police (high profile) to set speed traps in the area was made and PC Dennis said that plain clothes officers are in the area on various other projects. It was reported that police vehicles driving through the area do not appear to be stopping offenders that they see.
- Resolved that the Parish Council will act as liaison for residents to report incidents (JA/PN). Cllr Ashworth has contact details.
- Off Road Vehicles are creating a problem within the Country park. Their behaviour is intimidating as well as creating damage and general ASB. Police are not allowed to chase vehicles on the park. The Off Road Team is very small and has a huge area to cover. Resources are increasing and the more reports made will help get resources. There are boundary issues involved within the park area itself. Similarly Mill lakes is also in a different area.

• Regular events are being planned in Papplewick (Griffin's Head) which may affect Bestwood Village and create more traffic. Requested assistance in reporting any bad driving to help stop the events taking place. • Request for high vis policing take place (ie on foot) however officers need to be near their vehicles to react swiftly to callouts. Linked to undercover work taking place High Vis will jeopardise evidence collection. When possible patrols will increase. f) Storage room for Council property Still having difficulty getting access to Welfare room since November. Cllr Ashworth will have one last try. Action JA g) Playground inspections and repair Minuted earlier h) Christmas lights, invoice dispute Awaiting response to complaint i) Community events Council still to advertise a total  $\pounds$ 2,000 fund available to local groups for events.
